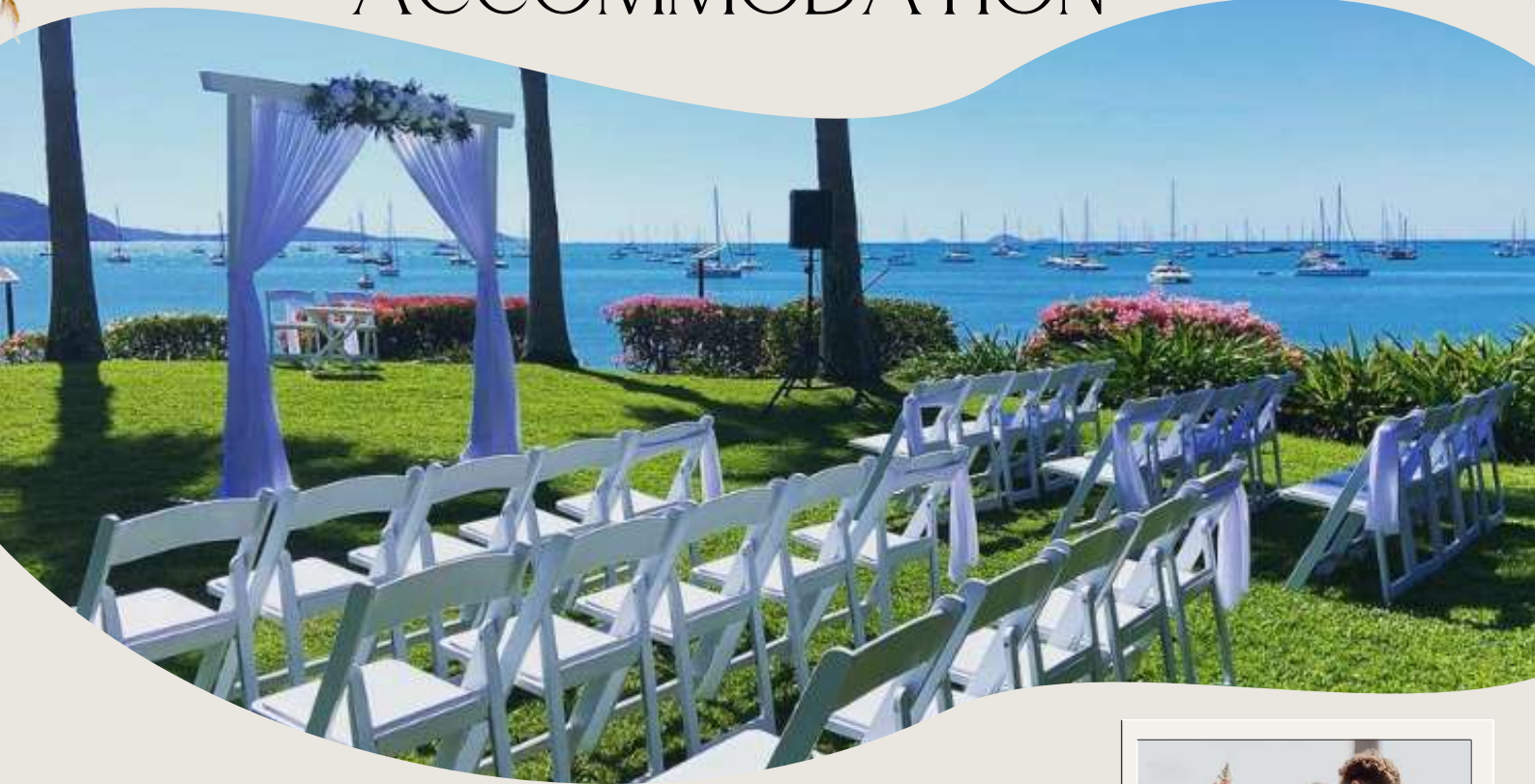
Waterside Lawn Wedding Ceremony Package

- Cost \$3500 (blockout dates apply)

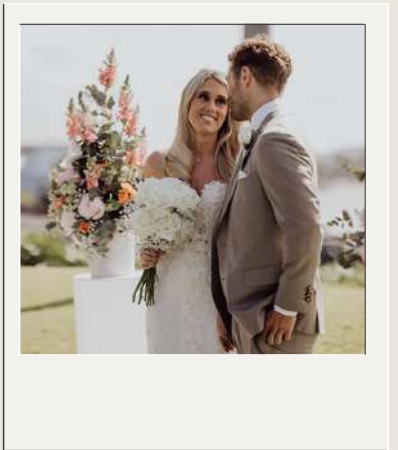

TERMS AND CONDITIONS

Mirage Whitsundays is delighted that you have chosen us to host your upcoming wedding ceremony.

TENTATIVE HOLD

To give you the opportunity to double check everything, we can place a tentative hold on your preferred date for a period of seven (7) days. Mirage Whitsundays reserves the right to remove a tentative booking after it has been held for seven (7) days, without notice.

BOOKING A booking is only considered confirmed by the payment of the full amount by you, and upon receipt by Mirage Whitsundays.

WEDDING CEREMONY

Guests are allowed access to the ceremony lawn via Villa 23 only. There is no access from the park. Members of the Bridal Party, Suppliers and Guests must not walk on the lawns in front of other apartments/Villas. Only guests booked into accommodation at Mirage Whitsundays are allowed access to the wider resort grounds (Pools, Gym etc.)

MUSIC

Music is permitted for the ceremony only and is subject to the resorts noise policy.

TERMS AND CONDITIONS

TIMES

Access to Villa 23, commences at 2pm on the date of first night of the booking. Access to the Ceremony Lawn commences at 8am on the day of the ceremony and must be adhered to.

The ceremony is limited to a 3-hour session (not including set-up and pack-down).

PARKING

Only guests who are booked into and registered in accommodation at Mirage Whitsundays may use the onsite car parking. Other guests will be required to park at adjoining public carparks or organise transfers through the wedding coordinator.

FACILITIES

Mirage Whitsundays offers public toilets located next to reception. Wedding guests will be allowed to use these amenities but must, at all times, access the waterfront through Villa 23. Should the public amenities not be sufficient for the wedding guests, the amenities in Villa 23 or other booked units will be required to be used.

ALCOHOL AND FOOD

Food and Beverage service is not permitted on the ceremony lawn, we ask that any food and beverage be served in Villa 23.

TERMS AND CONDITIONS

FINAL NUMBERS: You must advise us final guest numbers at least fourteen (14) days prior to the wedding date. You agree that the maximum number of persons on the ceremony lawn (including bridal party, children, photographer/s and celebrant/s etc.) is 50 persons. To comply with Body Corporate regulations, the maximum number of guests must not be exceeded. Mirage Whitsundays reserves the right to request additional guests over and above the maximum of 50 persons to vacate the ceremony lawn.

RUBBISH REMOVAL

Guests and wedding organisers are to ensure that all debris and rubbish will be collected from the ceremony lawn and adjacent gardens and left in the condition it was found. Additional cleaning charges will apply if the clean-up is not deemed satisfactory.

BOND

We will not charge you an upfront bond prior to the wedding. However, credit card details must be provided to cover any damage to the venue, thefts, excessive cleaning, or other incidentals. The supplied credit card will be charged to cover these costs. You will be notified before any such charge is made.

DAMAGE

We shall not be responsible for loss of, or damage to, property left on the premises prior to, during or after the function. The client accepts responsibility for any damage or theft to the premises or its fittings or equipment caused by the client, client's guests or by outside contractors engaged by the client prior to, during or after the function. The client is required to inform all relevant persons involved in the organising of the function, whether colleagues or contractors, of these Terms & Conditions.



TERMS AND CONDITIONS

SMOKING

Smoking is not permitted in any indoor facility on the Mirage Whitsundays property and is not permitted on the wedding venue lawn. There is a designated smoking area which everyone must use. Mirage Whitsundays may remove any person breaching this condition from Mirage Whitsundays property.

PRICES

All prices are GST inclusive. All prices stipulated on this contract shall be adhered to. Any other prices or optional extras are listed separately and are subject to change without notice.

CANCELLATIONS

Bookings are non-transferrable. Notice of cancellation of a wedding booking must be made in writing and received by Mirage Whitsundays. In the event that you cancel your wedding ceremony package booking with us the following cancellation policies apply:

(a) If you cancel your wedding ceremony booking on a date that is more than four (4) months prior to the booked date:

(i) A cancellation fee of 25% of the Ceremony Package applies

(ii) If we are able to re-book the date of the Cancelled Function with another comparable function for the reserved dates we will refund all fees less a \$200 administration fee.

(b) If you cancel your Cancelled Function on a date that is less than four (4) months prior to the Booked Date, you will forfeit all amounts paid for the ceremony package.





TERMS AND CONDITIONS

ALTERATIONS TO CONTRACT Any alteration to these terms and conditions must be in writing and signed by both relevant parties.

DECORATIONS

All decorations must be checked for their suitability with Mirage Whitsundays, and set up at a time deemed suitable. No paper confetti, rice or glitter throwing is permitted – however fresh rose petals or bubbles are acceptable outdoors. You will be liable for any breach of this and damages and additional clean up costs caused will be charged to the credit card on file. Mirage Whitsundays reserves the right to alter the décor, fixtures and fittings within the property at any given time without notice to you.

NO LIABILITY

(1) To the fullest extent permitted by law, Mirage Whitsundays and its employees, agents or contractors, will not be liable to you or any guests, invitees and/or any other persons who attend the function for any loss and/or damage of any nature (howsoever caused) or any damages (including, but not limited to, any special, consequential, incidental, exemplary, punitive and/or indirect damages) arising from, in respect of or in any way related to your use of Mirage Whitsundays property and/or the function however caused, however liability is asserted (including, but not limited to, in tort (including in negligence), under statute and/or general law) and irrespective of whether you have been advised of, or otherwise might have anticipated the possibility of, any loss or damage.
